



**APTA EXPO 2021
Visor Photo Contest
Official Sweepstakes Rules**

1) Description of Sweepstakes: No Purchase Necessary.

The American Public Transportation Association (APTA) (the "Sponsor") is offering the "Visor Photo Contest" (the "Sweepstakes") and will award a Grand Prize from valid entrants.

The Sweepstakes is available only to those who "like" the APTA Facebook page online (www.facebook.com/AmericanPublicTransportationAssociation), "follow" the APTA LinkedIn page online (linkedin.com/company/american-public-transportation-association) or "follow" APTA on Twitter (@APTA_info), photograph themselves with their EXPO 2021 visor and upload it to the applicable social media channel using the #APTAEXPO hashtag. The Sweepstakes is scheduled to begin at 6:00 PM Eastern Time October 13, 2019 with a deadline for entry of 11:59 PM Eastern Time January 15, 2021. The selection of the winner will be announced no later than January 31, 2021. Winners will be notified via phone, social media or email. Winners will be selected by the Sponsor and not by a random drawing or other element of chance.

2) Eligibility: Sweepstakes open to U.S. citizens, 21 years of age or older who "like" or "follow" the APTA Facebook page, LinkedIn page, or Twitter handle.
